SUBJECT: **NOMINATIONS FOR THE ADJUNCT FACULTY ASSOCIATION OFFICERS**

We, the Elections Committee of the Adjunct Faculty Association, as instructed by the Executive Board, officially and formally announce that elections for AFA Officers (President/Vice President, Treasurer and Secretary) will be held on or about October 19, 2016. The terms of office will begin on January 1, 2017 and end on December 31, 2019. A candidate must have been an AFA member in good standing for at least one year prior to running for office. The candidate must be a working member or on release time, or on special assignment for the AFA at the time of the election. Additionally, no officer shall be a candidate for or hold more than one elective office simultaneously nor serve as a department chairperson. Candidates for the President and Vice President positions must run as a team. The Duties of Officers can be found in Article VI of the AFA Constitution which can be found on the AFA website, <http://myafaonline.org>, under the Documents tab.

If you are interested in becoming a candidate for these positions the following is required:

PLEASE READ ALL INSTRUCTIONS CAREFULLY, FAILURE TO COMPLY WITH THESE SPECIFIC INSTRUCTIONS COULD INVALIDATE YOUR PETITION.

- Copy and print the **Nomination Petition** form which can be found on the AFA website, <http://myafaonline.org> under the AFA Documents tab.
- Secure dated signatures of at least 25 AFA members in good standing. It is suggested you ask them to print NEATLY and then sign and date so eligible voters can be verified. Names that are illegible will invalidate the signature.
- **Signatures acquired PRIOR to the date of this notice WILL NOT BE ACCEPTED.**
- As per the AFA Constitution, Article V section 2, completed, **ORIGINAL** nomination petitions (keep a copy for yourself) must be submitted at the October 15, 2016 Representative Assembly meeting between the hours of 8:30 AM - 11:30 AM. This meeting will be held at the Greenvale Townhouse Diner, 49 Glen Cove Road, Greenvale, NY 11548 (516-625-5300.)
- Each candidate may submit with their petition a typed statement of no more than 100 words, which will be sent to eligible voters along with the ballots.
