Departing from the rigid constraints of the former system, which occasionally posed challenges in aligning with class offerings, this update empowers adjuncts to tailor their schedules with more precision. This flexibility acknowledges the varied commitments of our adjunct faculty, contributing to a more harmonious integration of personal and professional responsibilities.

Equally commendable is the autonomy granted to adjuncts to independently cancel and resubmit availability without the need for a help desk ticket. This self-service functionality acknowledges the importance of time management and ensures that adjustments can be made swiftly within the submission period. It's a practical feature that resonates with the AFA, reflecting a commitment to providing adjuncts with the tools to navigate administrative tasks efficiently. Moreover, the ability to differentiate between asynchronous and synchronous distance education availability addresses the evolving landscape of online education. This nuanced feature ac-

# The Inside Scoop

The AFA has achieved a new milestone over the past few weeks. Our membership has grown to an all-time high of 1,759. This was achieved in part by our highest single semester recruitment of 56 new members.



This made me recall events of the not too distant past. During the Fall of 2014, the AFA had its first contested election in its history for the leadership positions of the union. It was a hotly contested election and,

at times, volatile. When the election concluded, a new leadership team was put into place. In the days following the election, I wrote the narrative of the flickering flame. Because of the volatile nature that that campaign took on, I wrote of the aftermath: As the sun rose on the land, one could see a scorched earth but, in the distance, a flickering flame existed. That flickering flame was all that was left of the passion of a once great union. That day, I challenged the 790 AFA members to nurture that flame and keep it burning until it once again became a raging fire of passion and resolve that the AFA was always known to be. The members came and did just that.

In the months that followed, the AFA regained its majesty, and more and more individuals came aboard the "train" and joined our ranks. I promised all adjuncts that that train would continue to return to the station and continue to put out the welcome mat, inviting them to come aboard and join our union family. That train welcomed more and more adjuncts with every visit to the station. Not even in my greatest imagination did I think that our ranks would add almost 1,000 new members in just a handful of years.

Today, our union stands strong and tall thanks to the support of 1,753 members.
