#### Don Clavin Candidate For Town of Hempstead Supervisor

I AM RUNNING FOR THE SUPERVISOR FOR THE TOWN OF HEMPSTEAD, WHICH IS SITUATED BY NASSAU COMMUNITY COLLEGE. TO ME NCC HAS BEEN THE LIFEBLOOD FOR ALL THE RESI-DENTS OF THIS GREAT TOWN AND COUNTY. I HAVE ALWAYS BEEN AND WILL CONTINUE TO BE A GREAT SUPPORTER OF NCC.

IF ELECTED AS TOWN SUPERVISOR MY TEAM WILL LOOK FOR BETTER WAYS TO ENGAGE THE COLLEGE THROUGH INTERNSHIPS FOR STUDENTS AS WELL AS EMPLOYMENT OPPORTUNITIES UPON GRADUATION.

As the Town Receiver of Taxes I have dutifully serving the residents of America's largest township since 2001, making the process of paying property taxes more convenient. Additionally, I have helped thousands of home-owners to lower their taxes by hosting seminars on challenging property tax assessments and filing for property tax exemptions.

As Receiver of Taxes, I was committed to enhancing service while being fiscally responsible. Under my leadership, two satellite tax offices were created in Lawrence and Hicksville, in addition to extending office hours from 8 a.m. to 6 p.m. during the tax payment seasons for the convenience of taxpayers. I utilized Hempstead Town's Mobile Town Hall to collect taxes at various senior citizen centers and other convenient locations. I also implemented e-mail and text message reminder programs to help taxpayers make timely tax payments. These initiatives are just a few of the many ways I worked to make the tax office more accessible to the Town's residents. For my accomplishments, I was named one of "Long Island's 40 rising stars" by Long Island Business News.

After the terrorist attacks of September 11, 2001, I successfully urged former Gov. George Pataki to sign an executive order that extended time for tax payments for the affected families. In 2002, I proposed and obtained state legislation known as "The Clavin Law," that requires banks to be financially responsible for residents' tax penalties if they do not notify their mortgage customers of their legal rights and responsibilities upon approval of their mortgage.

Long a champion of the taxpayer, I recently crafted legislation to eliminate the 10-year "sunset" clause for Hempstead Town's veterans receiving the Cold War Veterans Property Tax Exemption. Approved by the Hempstead Town Board in March 2018, Hempstead Town's qualifying veterans will now be granted the exemption permanently as long as the veteran or un-remarried surviving spouse remains a homeowner.

Most recently, I lobbied for state and county support to increase income eligibility levels for the Senior Citizen Property Tax Exemption and the Persons with Disabilities and Limited Incomes Exemption. The increased in-

come eligibility levels would bring Nassau in line with New York City eligibility limits. The proposed legislation would provide Nassau homeowners with the same level of property tax relief that our neighbors in New York City currently enjoy. I am especially proud to say that I partnered with NYS Assemblywoman Missy Miller, to put forth a proposal to amend to the Home Improvement Tax Reduction for the Physically Disabled Exemption

I also earned valuable experience in local government while working in the Office of the Nassau County Attorney as Deputy County Attorney. There, I was responsible for defending various agencies of government ranging from the Department of General Services to the Nassau County Police Department.

#### Kate Murray Candidate For Hempstead Town Clerk

As one of seven children born to an FBI agent and a homemaker, NCC represented an excellent way to receive the best education at the lowest possible cost. After receiving their Associates Degrees two of my brothers moved on to the University of Massachusetts and University of North Carolina at Chapel Hill, and a sister of mine graduated from NCC and moved on to Cornell University. Lastly, and in an example of the broad spectrum of students that NCC attracts, my mother attended NCC in her middle years after having raised seven children. I know firsthand how important it is that all have access to affordable quality education and that we must support the staff, full-time and part-time, that make dreams of a better life a reality. We must always work to make sure residents have the opportunity to achieve their fullest potential in life. My appreciation to AFA for inviting me to submit this statement.
