I remembered that we had just completed a successful season playing out-door soccer and, now, for the first time, we were going inside to play in a tournament held at North Babylon High School. Because of our success outdoors, I and the boys were confident that we would do well in this tournament. I gave the best pep talk I've ever given. The boys were pumped. They were "psyched" as they were announced, and ran out to play their first match. We proceeded to lose that game and the four other games we played that day. To say that we left the gym dejected would be an understatement.

Not long ago, a question from my now forty-seven-year-old son who is coaching his son's soccer team, came from out of the blue. "Dad, remember when we played in that indoor tournament at North Babylon High School?" "Yes," I answered. My son went on, "I remember your speech before the game; it was great. We all went out there ready to kick butt and we lost every game. Why?" My answer was simple: "We didn't have the skills needed to play indoor soccer."

Here I am a new coach so to speak with a new team. The "tournament" we entered a year and two months ago is very different from any we'd played in before, yet we have had some very good success. I asked myself why. The answer was plain and simple. All--and I mean all-the players have brought their "all-star skills" to the playing field; all-star skills that have in, at least some

cases, worked miracles in this new and different game. By design and through some luck, a team of AFA leaders, some elected, some appointed, and many who have volunteered their services, has been assembled, who on a daily basis are motivated, work hard and, most importantly, make each other better. 
### AFA Members Approve All Proposed Amendments

#### **AFA Member Spotlight:** Joyce Culver

For Joyce Culver, her pictures are worth....well, recognition, art, a career and fodder for her students. Culver, who has taught in the Department of Art at NCC since 1980 and has been an AFA member for over 20 years, holds a BS in Art Education, SUNY College at Buffalo, NY and an MFA in Photography, Rochester Institute of Technology, Rochester, NY. She also studied at the Institute del' Arte, Siena, Italy. Culver teaches at the School of Visual Arts as well as NCC, where she has been teaching photography for over 25 years and digital photography, Art 159: Digital Photography, to Photography majors and non-majors. This course includes learning how to use the 35 mm DSLR and Adobe Lightroom and Photoshop. As Culver explains, Art 159 is a basic course for all students who want to learn about the camera and computer programs that support editing digital files and manipulating them.

Looking at her biography, resume, exhibition listings, grants and numerous works on her website, one can find the depth and breadth of her work, accolades and career that spans more than 40 years. Culver made her professional debut in the book and exhibition, *The New Color Photography* in 1977 with her color studies of objects in the landscape titled "*The Secret Soul of Things*." Joyce's early 1990's portraits of lesbian and gay couples explore power and dialog in relationships, acknowledging how love and commitment might look in this community at a time when it was not discussed. On-stage and candid "green room" portraits of celebrities, shot exclusively for the 92nd Street Y since the year 2000, capture creative talent in revealing moments of character. Currently, Joyce is working on a portfolio and book, *The Lulu Diaries*, about her beloved pet Lulu, a Senegal parrot who

in 2014 flew away after 17 years of companionship. Culver's photographs are in the permanent collections of the Amon Carter Museum, the International Museum of Photography at the George Eastman House, MOMA, and in numerous private collections. She has received artist grants from the New York Foundation of the Arts to support her projects. Publications include: *The Arc of Love, Butch/Femme, Exploring Color Photography, Forbes, Fortune, Newsday, New York, The New York Times, Art News*. Clients include: The 92nd

Street Y, Businessweek, Stem Cell Foundation, Allen & Co., The Jewish Theological Seminary, The New York Times, University of Medicine & Dentistry of New Jersey, Cornell University and others. This professional photographer works mainly in portraiture and is hired by both corporate and private clients. Culver relates her experiences in the field in her classroom, and her students seem to relish her stories. And what stories she likely has to tell, as she chronicles numerous celebrities who appear at the 92nd Street Y in New York City, among other gigs. Her recent work involves photographing icons in the fashion industry. Seventeen of Culver's photographs appear in the book *Fashion Lives*, published by Rizzoli in May 2015. Each of these seventeen photographs opens the respective chapter for a fashion person profiled in the book. Over a period of several years, Culver shot stage photographs of these people who were interviewed at the 92nd Street Y in New York City by fashion maven Fern Mallis, the author and interviewer. Mallis herself stands as an icon in the fashion industry, having pioneered various industry organizations and created the New York Fashion Week.

Regarding shooting all these personalities at the 92nd Street Y, Culver explained that the fashion people spoke on stage about how their careers were formed, and in the book their stories were transposed from the stage interviews. Culver gushes, "For someone who wants to learn about how a career in fashion is formed, the book is excellent!" And for someone who wants to learn about photography, Joyce Culver's classroom is the place to be.

When he is not in court or attending task force meetings, Nassau County Assistant District Attorney

René Fiechter can be found teaching one course during two semesters a year as an adjunct in the Department of Criminal Justice. Fiechter joined NCC within the past ten years, having also worked as an adjunct at CW Post, and also serves on the Graduate Faculty Advisory Board for Criminal Justice at Molloy College. Fiechter's academic credentials boast a BS in Economics from the Wharton School of the University of Penn-

sylvania, a JD from Hofstra University's School of Law—of which he was a member of its second graduating class—and a LLM from New York University's School of Law with a focus in Criminal Law.

Fiechter was appointed as New York State Co-

Chair for Fight Crime: Invest in Kids, which is a national, bipartisan, nonprofit, anti-crime organization. The organization has a membership of nearly 5,000 police chiefs, sheriffs,



district attorneys, other law enforcement leaders and violence survivors. The members take a hard-nosed look at what approaches work—and those that don't—to prevent crime and violence. They then rec-

ommend effective strategies to state and national policymakers. Fight Crime: Invest in Kids operates under the umbrella of the Council for a Strong America. René also serves as President of the American Academy for Professional Law Enforcement and directs the Nassau County Heroin Prevention Task Force as well as the LI Youth Safety Coalition.

Recently, Fiechter was also honored by STRONG Youth at their 15th year Gala

as the recipient of their Matthew Simeone Award for outstanding services to youth through Law Enforcement. STRONG is Long Island's leading gang prevention youth agency, and the late Matthew Simeone was a legendary NCPD officer with whom

René had the privilege of partnering on a range of innovative community crime prevention projects.

#### **AFA Member Spotlight:** Delores V. Smalls

For the past 47 years, Delores Smalls has been serving NCC, as both a full and adjunct professor, for which she regularly teaches NCC 101 and SPS 093. NCC awarded Smalls two Faculty Grants. In 1998 she garnered the award for her multi-media project "Promises Made... Promises Kept... A Reflection of African American Women of Long Island." Then in 2015, Smalls' project presentation, "Intersections: Spirituality, Culture, Academics, Careers," secured her second grant. The presentation saw participants, including NCC alumni, faculty, students and community leaders, discussing the generational effect and impact of NCC and communities of the African Diaspora.

Just as her academic work clearly shows a reach from NCC into the community, Smalls, in her many duties outside NCC, ensures a tie to NCC, enriching and aiding students' and many others' lives.

Delores proudly serves as a member of the Board of Trustees of the Family & Children's Association, the largest private social service agency on Long Island. Since 1998 she has been mentoring and been a liaison for the agency's youth and adult clients who apply to and attend NCC. In addition, Smalls acts as the scholarship liaison to NCC for the National Coalition of 100 Black Women, L.I. Chapter. This organization donates \$2,000.00 in scholarship funds biannually, to the NCC Foundation, having begun this practice in 1995. As President of the Central Nassau Club of the National Association of Negro Business & Professional Women's Clubs, Inc., she initiated a partnership between the NCC music faculty and the organization for its classical vocal arts program. Each spring semester over the period from 2012 to 2015, two students were selected to perform at local and regional programs and awarded scholarships of \$200.00 to \$1,000.00.

#### **AFA Member Spotlight:** Dr. Philip M. Cheifetz

Forty-nine-year member of the Mathematics Department, Dr. Philip M. Cheifetz, received the prestigious SUNY Distinguished Service Professorship in 2008. Cheifetz holds a B.A. from Wilkes University, a M.S. from Hofstra University, and a Ph.D. from the University of Sarasota.

So what are some of the accomplishments that led to his 2008 distinction? Cheifetz's career at NCC

features extensive service in all facets of the mathematics profession. As a writer of materials for the Harvard Consortium and a spokesperson for "Harvard Calculus," he helped to systematically change calculus instruction in the United States, based, in part, on the NCC/Harvard approach. During the summers from 1996 to 2005, he also taught at Harvard's JFK School of Government. Phil played a seminal role in the creation of the American Mathematical Association of Two-Year Colleges, serving as its president in

1978 and its executive director from 1979 to 1983. At NCC, he established the High School Partnership Program in Mathematics. In addition, Dr. Cheifetz has served as a consultant to various organizations, including Pfizer and the Columbia University School of Public Health. Furthermore, in 1987, at the request of the Chinese Association of Science and Technology, Phil was a mathematics delegate to the People's

Republic of China for a three-week visitation. Additionally, Dr. Cheifetz is a prolific scholar with numerous research articles and eighteen co-authored or edited textbooks to his credit. Among his countless other accomplishments, Dr. Cheifetz has been the recipient of ten national mathematics awards and five grants, including two from the National Science Foundation.

#### **AFA Member Spotlight:** James Coll

James Coll is a fitting example of a NCC graduate coming back to his alma mater and doing good for the community. Coll earned an AS in Criminal Justice from NCC, a BA in History from Hofstra University and a MA in History from Hunter College. He then continued past his Masters at various schools, concentrating on American Constitutional History, and currently holds 30 graduate credits above the MA.

Since 2001, Coll has served as an adjunct in the History Department teaching American and Constitutional history. In addition to giving back to NCC, Coll decided to launch a statewide effort. In 2013, he formed a not-for-profit called ChangeNYS.org, dedicated to promoting civic education in New York State. According to Coll, the goal of ChangeNYS.org is "to prompt non-partisan conversations in our communities about government in Albany and how it affects us." He looks forward to having more discussion and welcomes people to check out the website to see what his group is about and how they can be part of the dialogue.
